

**EMPLOYMENT AGREEMENT  
FOOD SERVICE DIRECTOR  
2021-2022**

This Employment Agreement is between the South Central Community School Corporation, hereinafter called employer, and **Karen Hagenow** who is employed in the position of Food Service Director under this agreement for the years beginning July 1, 2021, (each full year consisting of 230 days) and **continuing until June 30, 2022. Effective July 1, 2021 salary has been set at the sum of \$52,000 for 2021-2022** per year for the period of this agreement.

Fringe benefits covered by this agreement are as follows:

1. **PTO Days:** Fourteen (14) Paid Time off Days are granted each year. Unused PTO days will accumulate as sick leave days accumulating from year to year up to a maximum of ninety (90) days.
2. **HEALTH/LIFE/LTD INSURANCE:** Major family medical insurance coverage benefits will be provided through the current corporation carrier. The corporation contribution will be \$5,004 annually with the employee responsible for payment of the remainder of the annual premium. Non-contributory term life insurance in the amount of \$50,000 and \$50,000 of accidental death coverage are provided at a \$1.00 cost the employee per year. Long-term disability insurance will be provided at a \$1.00 cost to the employee per year.
3. **RETIREMENT:** The employer shall pay on behalf of the employee to her entire annual contribution to the Indiana Public Employees Retirement Fund. The employee's 3% annual annuity contributions will be withheld post-tax each pay period and remitted to PERF.
4. **MILEAGE REIMBURSEMENT:** The employee may charge mileage for school related transportation services at the IRS reimbursable rate.
5. **CELLULAR TELEPHONE:** The employer will provide the employee a monthly cell phone reimbursement in the amount of fifty dollars (\$50.00) for such use in school communications and necessary communications away from school. Such reimbursement will be made on a semi-annual basis (December and June).
